STANDARDS

Conduct:

Students must maintain a high standard of conduct and behavior consistent with men and women who are ministers of the Gospel. We request our students to strive to maintain a walk of holiness and righteous living.

Students shall render all due respect to the faculty and staff of PROMISE at all times, understanding it is a **privilege** to be accepted as a student.

Christian Service:

All students are required to be actively involved in a local church where they must be involved in Christian service. All students are required to obtain the ministerial recommendation of their pastor or an ordained minister that has known them on a personal basis for a minimum of two years.

Enrollment:

PROMISE must receive the following items for the student to be considered enrolled:

- A. Application with enrollment fee (required)
- B. Ministerial Recommendation signed and completed by their Pastor (required)
- C. Complete Ministerial and/or secular resume (required)
- D. Copies of transcripts and degrees (if any)
- E. Copies of certificates of completion and awards (if any)
- F. Please retain copies of report cards, receipts for proof of attendance and completion of this class.

Until PROMISE receives the above items in it's entirety, the student's status shall be considered pending or probationary (unless waived by the school).

Nondiscriminatory:

PROMISE does not discriminate on the basis of race, color or ethnic or national origin in the administration of our educational policies and/or programs.

Right to Refuse:

PROMISE reserves the right to refuse anyone, for any reason, not in harmony with the principles, standards or purposes of this school and organization. In such case, monies paid will be returned in full.

H S Diploma:

A high school diploma, G.E.D. or other demonstrated equivalency is required to enroll in PROMISE.

Accreditation and Registration:

Student understands that Promise International University is an affiliate of Promise Christian University and is registered with the State of California at the Bureau of Private Post Secondary and Vocational Education as a Religious Exempt School and is permitted to issue those degrees listed in its current catalog. PCU is not regionally accredited and cannot issue I-20 forms. PCU will be seeking Christian accreditation and will be working to achieve accreditation from recognized non-regional Christian accrediting association in a normal time frame.

Statement of Faith:

Students are asked to review and acknowledge PROMISE'S statement of faith.

Payment of Tuition:

Students shall pay tuition on a pre-determined payment schedule. All classroom instruction fees shall be paid for at the time taken. Students enrolled in the degree program pay classroom instruction fees which are deducted from their tuition. Non-degree students such as certificate students pay the required classroom fees, registration and certificate fees but receive no credit for classes taken unless they enroll as a degree program student. Audit students are accepted on a limited basis and must have the permission of the instructor and their own pastor to audit. All tuition and fees must be paid by June 30th and prior to the issuing of a Graduation Accuracy Form which officially clears the student for graduation.

Transcripts:

No partial or complete transcripts can be requested until tuition and fees have been satisfied for classes completed.

(INTERDENOMINATIONAL - BIBLE BASED)

THE HOLY SCRIPTURES

We believe the Bible is inspired of God (2 Timothy 3:16,17).

THE ETERNAL GODHEAD

We believe in the one true God, creator of heaven and earth, redeemer of mankind, a triune God: Father, Son and Holy Spirit (2 Corinthians 13:14).
